8. ORDINARY RESOLUTIONS

To consider and if thought fit to pass the following Ordinary Resolutions:- Ordinary resolutions as follows:

"That pursuant to Section 10(1) (i) of the Registered Club's Act, which states as follows:-

"(i) A member of the Club whether or not he or she is a member of the governing body, or of any committee, of the Club shall not be entitled, under the rules of the Club or otherwise, to derive, directly or indirectly, any profit, benefit or advantage from the Club that is not offered equally to every full member of the Club."

The members of the Shoalhaven Ex-Servicemen's Club Ltd approve that the Board of Directors and Senior Management, during the 12-month period following the 2023 Annual General Meeting, receive the following benefits:-

- a) The Provision of reasonable meals and beverages at Board meetings.
- b) The provision of reasonable expenses in travelling to and from Board meetings or any other constituted meetings or duties as approved by the Board from time to time on the production of invoices, receipts or other proper documentary evidence of such expenditure.
- c) The provision to the Board of Directors and invited guests with two Board dinners per annum.
- d) The reasonable cost of Directors & Spouse attending the Annual General Meeting of Clubs NSW and the RSL and Services Clubs Association per the training and study tour policy.
- e) The reasonable cost of Directors & Spouse attending seminars, lectures, trade displays, organised study tours, fact-finding tours and other similar events domestic or international as may be approved by the Board from time to time per the training and study tour policy.
- f) The provision of a uniform consisting of a suit, shirts and a tie for Directors and Life Members.
- g) The provision of a Christmas gift voucher of \$50 to Directors and Life Members.
- h) The provision of reasonable expenditure on food and refreshments for Directors and Senior Management officers attending and/or entertaining dignitaries and/or guests of the Club at functions (whether on Club premises or otherwise) including the Presidents ANZAC Day Luncheon, The Annual Corporate Suppliers Golf Day and other marketing or promotional events or activities provided such expenditure is approved by the Board from time to time as being reasonable and properly incurred.





- i) That all Club Directors receive, upon retiring from the Board and after having completed a minimum of five years continuous service, a farewell gift of appreciation to the value of \$500.00 and an extra \$100.00 per annum for each full year completed thereafter up to a maximum of \$3,000.00 in recognition of conspicuous service rendered to the Club."

Question:

Member was at Worrigee Sports last week and was surprised and disappointed that the Tim Tszyu fight wasn't being shown in the club last week. Why doesn't the Club utilise the function room to show the fights?

Reply by Bernie Brown: It is quite a balancing act on what fights to show. The cost to the Club to show the fights are close to \$2,000. Therefore, to make a return on investment, we need to drive at least double that in revenue just to make our money back. When these fights are coming up, we do speak to our management team and ask for feedback. For this particular fight, we didn't get any feedback from them about this being a viable event. We are happy to keep looking into this. This is the same for the UFC fights. We will look at televising the big events. The costs to televise are high for the Club.

Question: Regarding the proposed renovations at the Ex-Servos Club, what time frame are we looking at? Reply by Bernie Brown: The Board has completed annual strategic planning and met last week in a special property meeting. At this time, we have done some strong analysis around what we want to spend. Once we have started this analysis and we applied return on investment and cost frameworks at both venues, there was a concern around ongoing building code compliance, particularly at Ex-Servos Club due to its age c.1957 construction. When you do a certain amount of renovation or building work, you can be typically asked by council and certifiers to bring the building up to code. For example, sprinkler systems at a significant cost. Given the building's age, the works on this site have been placed on hold. The Board have been looking at Worrigee Sports and consider this to be a destination venue with sports, accommodation and multiple restaurants. When we applied the cost benefit framework to renovations to Worrigee Sports, it shows positive returns. The Board have resolved to look at a longer-term master planning project for the Ex-Servos club. Once you significantly renovate older buildings, it can become problematic. Smaller projects such as the golf course works have also been put on hold for the time being.

<u>Question</u>: When will we know what is happening regarding golf course renovations?

<u>Reply by Bernie Brown</u>: Bernie will organize to have communication out to members in the next week or so.
