### **GENERAL BUSINESS**

## The floor was opened for General Business.

Mr Alan Bird thanked John Newbold for his 23 years of service and congratulated him on retiring from the Board.

Question: Raised by Mr Robert Williams about the end-of-month draws and why the prize offering is \$500 at 1 club and \$1000 at the other club.

<u>Response</u>: Mr Bernie Brown responded. The Marketing Team look at different promotions at each club. The 2 clubs have different offerings. People have a choice as to which club they want to go to.

<u>Question</u>: Raised by Mr Chris Oliver. A question was raised about the Mother's Day raffle and the major prize associated with this.

<u>Response</u>: Mr Bernie Brown responded and thanked Chris for his feedback. This feedback will be given to the Marketing Team to look at the way it is run for next year.

Question: Raised by Mr Chris Oliver about the toy raffles.

<u>Response</u>: Mr Bernie Brown responded about how the toy raffles attract new people to the club and that they are extremely well attended. Toy raffles are a good promotion for the business.

Question: Raised by Greg Sturgiss. Asked for an update on Worrigee Sports renovations

<u>Response</u>: Mr Bernie Brown responded. There is a slight delay to the program due to the weather. From 1<sup>st</sup> July, the Peppertrees restaurant will be offline for months, due to the kitchen being upgraded. Growers will be operating through this period, as well as the Peppertrees kitchen operating out of the Smokehouse on a reduced menu. Trivia will be down at Growers on a Wednesday night. Looking for 1<sup>st</sup> November to re-open and renovations to be completed.

Question: Raised by Craig Howsan. Question about whether the builders will fix the roof at Worrigee Sports.

<u>Response</u>: Mr Bernie Brown responded. The building is 25 years old, and maintenance challenges come with that. The Board has approved a 'hit list' of items that need to be fixed in regard to the roof. Anchor points are currently being looked at to be installed on the roof to allow these maintenance items to be looked at.
